The three candidate municipalities for the European Volunteering Capital 2026 title are Ballina, Maia, Rzeszów.

The deadline for applications for the European Volunteering Capital 2026 was **June 3rd 2024.** The information provided in the application form will count as 70% of the final score allocated to each candidate. 30% of the score will be allocated based on the video and the presentation of the candidature during the EVCCC network meeting and EV Capital 2026 Candidates Presentation event **on September 10th 2024 in Brussels.**

The jury of key personalities connected with volunteering, representing civil society, the private and for-profit sector, as well as the EU institutions, will assess the candidates. The judging criteria is based on their strategies, policies, and programmes in connection to the Blueprint for European Volunteering 2030 and to the CEV Volunteering Policy Statements. Evidence about their engagement with, and support for, the European Solidarity Corps when the applicant comes from an EU member state is also required. Applicants are also asked to indicate if they are signatories of the Integrating Cities Charter.

The winner will be announced in Trento, Italy on November 29th 2024.
